

“WIN A WEEKEND AT BOTTLEROCK” SWEEPSTAKES - OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. This Sweepstakes is sponsored by Delicato Family Vineyards, 12001 S. Highway 99, Manteca, CA 95336 (the "Sponsor").

- 1. ELIGIBILITY.** Sweepstakes participation is open only to legal residents of the 50 United States and the District of Columbia (except Utah and where prohibited or restricted by law), 21 years of age or older at the time of entry. The “Win a Weekend at Bottlerock” Sweepstakes (“Sweepstakes”) begins 12:01AM Standard Time (“PST”) on February 1, 2017 and ends 11:59PM PST on April 30, 2017 (“Entry Period”). Electronic entries must be received by 11:59PM PST on April 30, 2017. All entries become the property of Sponsor and will not be acknowledged or returned.

The following individuals are not eligible: employees, contractors, directors and officers of Delicato Family Vineyards and each of its respective parent, affiliates, subsidiaries and web-design, advertising and promotion agencies, fulfillment, judging or other agency involved in the administration, development, fulfillment and execution of this Sweeps (collectively, “Parties”), and the immediate family members (parent, spouse, sibling, child, and their respective spouses or “step” of each, regardless of where they reside) and those living in their same households whether or not related. Licensed distributors or retailers of alcoholic beverages, and their employees, are not eligible. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who, within the past six (6) months, performed services for Sponsor, Agency or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying the prize, and/or their respective parent, affiliates, subsidiaries, and successor companies, and immediate family and household members of such individuals, are not eligible to enter or win. “Immediate family members” shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. “Household members” shall mean people who share the same residence at least three months a year.

- 2. TO ENTER.**

ONLINE

I. **FIRST REGISTER ONLINE:** Limit of one (1) registration per person or email address (“Entrant”) during the Entry Period. If you try to register more than one (1) time using different email addresses only the first registration will be accepted. Entrants must be the authorized account holder of the email account from which the entry is made.

a) Complete and submit the online entry form found at: www.bottlerocksweeps.com (the “Website”). Entrant must complete all fields in the online entry form or entry will not be accepted. If you do not have a computer or other device to access the Internet, many public libraries offer free access to computers and the Internet.

b) Or, you can enter the Sweepstakes by connecting with Facebook by clicking on the Facebook icon and accepting the permissions of the Facebook app (no installation will be required). If the

app is not accepted, Entrant will not have completed the process for a valid Entry. Entrant must complete all fields in the online entry form or entry will not be accepted. You must be a member of Facebook to enter using your Facebook Login; there is no fee to become a member. Your participation on Facebook must comply with the Terms and Conditions posted on www.Facebook.com. You are providing your entry information to Sponsor and not to Facebook.

ALTERNATIVE METHOD

One mail-in entry for this method only for the Entry Period. Group and mechanically reproduced entries, including photocopies, are not eligible. All mail-in entries must be postmarked by April 30, 2017 and received by May 4, 2017.
- c) Click to share via email and earn one (1) additional entry for the duration of the Sweepstakes. Instead of sharing via email, you may hand print full name, zip code, telephone number, email address and date of birth on a plain 3" x 5" card and mail it to: Delicato Sweepstakes "Win a Weekend at Bottlerock" Sweepstakes Email, PO Box 280267, Nashville, TN 37228. One mail-in entry for this method only for the Entry Period. Group and mechanically reproduced entries, including photocopies, are not eligible. 2017.

TEXT

Enter using your SMS-enabled mobile phone to text "BOTTLEROCK" to shortcode 24587. You will receive a reply text message with a link to www.bottlerocksweeps.com containing the official entry form to submit entry including your full name, zip code, telephone number, email, and address. Entrant must confirm they are 21 years of age or older. Entrant must complete all fields in the online entry form or entry will not be accepted. Limit one entry per person or email address per day during the Entry Period. Participants must have a mobile phone with text messaging and web browsing capabilities to enter and may incur a standard text message and/or data charge from their wireless service provider for each message sent and received. Check with your wireless service provider for details on these and other applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate. Texting Entrant must be the authorized account holder of the account from which the Entry is submitted.

- 4. PRIZES.** There will be a total of one (1) Grand Prize offered in the Sweepstakes. Grand-Prize

winner will receive two (2) 3-day VIP tickets to Bottlerock May 26-28, 2017, four (4) nights hotel accommodation in Napa, and a \$1,500 gift card to cover travel and incidentals. Approximate Retail Value ("ARV") of Grand Prize is \$4,952. Alcohol is not part of the prize.

No substitution or cash equivalent of prize is permitted except at Sponsor's sole discretion. Winner is responsible for any and all federal, state and local taxes or assessments and any person winning over \$600.00 in prizes will receive an IRS Form W-9 from Sponsor for the calendar year in which the prize is awarded. Odds of winning depend on the number of eligible entries received. Winner and guest must both be 21 years of age or older.

- 5. WINNER SELECTION.** Potential winner will be chosen in a random drawing from all eligible entries received on or about May 9, 2017. Winner will be drawn by an independent judging organization whose decision with respect to the selection of the winner and the interpretation of these rules and regulations will be final. Winner will be notified by telephone and/or email. Winner will have 48 hours from time of initial notification to respond. If winner does not respond within the 48 hours or an email notification is undeliverable after up to three (3) attempts, a new winner may be selected. Winner and winner's guest will be required to sign and return an Affidavit of Eligibility, Acceptance of Conditions, and Liability/Publicity Release (where allowed by law) within three (3) calendar days. If potential winner does not return fully executed paperwork within three (3) calendar days, winner may be disqualified and an alternate winner may be selected.
